Depending upon the type of policy, navigate among our wide range of external funds, access real time information on fund performance and compare different funds (Quick Rank, in partnership with Morningstar)



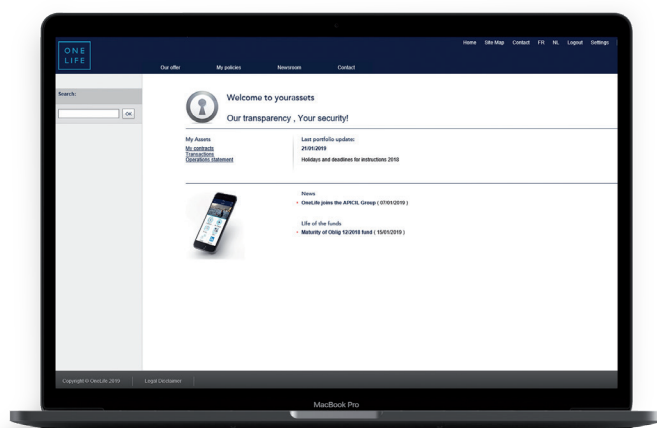
Monitor your life assurance policy

- Track the status of your operations



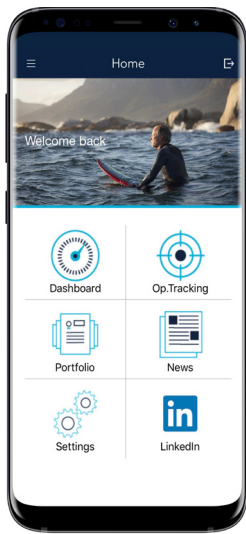
